Chapter 11.95 RCW: POWERS OF APPOINTMENT
In 1910-11, the House revolted against Cannon, stripping the Speaker position of many powers (like the right to appoint members to committees and a position in the Rules Committee), and adopted the caucus system again, but members soon dropped it; also, the power of committee chairmen rose because they could control what was discussed.
