RESOLUTION NO. 16-0059-2022

After due deliberation of the Sangguniang Panlungsod of the City of Lapu-Lapu, on motion of Hon. Annabeth D. Cuizon duly seconded by Hon. Marciano A. Alforque, Jr.,

RESOLVED, to enact, as it is hereby ENACTED the following:

ORDINANCE NO. 16-004-2022

AN ORDINANCE APPROVING THE DEVOLUTION TRANSITION PLAN OF THE CITY OF LAPU-LAPU

WHEREAS, Executive Order No. 138, s. 2021 orders the full devolution of functions, services, and facilities by the national government to local government units not later than the end of Fiscal Year 2024. These shall include those devolved responsibilities indicated in Section 17 of RA 7160 and in other existing laws which subsequently devolved functions of the national government to local government units. These fully devolved responsibilities shall be funded from the share of the local government unit in the proceeds of the national taxes and other local revenues;

WHEREAS, this Executive Order stemmed from the Supreme Court decision in the consolidated cases of Congressman Hermilando I. Mandanas, et al vs. Executive Secretary Paquito N. Ochoa, Jr. et al and Honorable Enrique T. Garcia, Jr. vs. Executive Secretary Paquito Ochoa, et al and clarifies the basis for the computation of local government shares and ordered the national government to include all collections of national taxes in the computation of the base amount for the just share of local government units;

WHEREAS, Section 10 of Executive Order No. 138, s. 2021 orders all local governments to prepare their Devolution Transition Plans (DTPs) in close coordination with the national government agencies concerned especially with regard to devolved functions and services that are critical to them;

WHEREAS, DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 requires all local government units to prepare their Devolution Transition Plans (DTPs) to ensure a strategic perspective and systematic and coherent actions towards their full assumption of devolved functions and services starting in Fiscal Year 2022;

NOW THEREFORE, Be it ordained by the Sangguniang Panlungsod of the City of Lapu-Lapu, that:

SECTION 1. The Devolution Transition Plan of the City of Lapu-Lapu is hereby approved.

SECTION 2. This ordinance shall take effect upon its approval.
